Information

Initiation Fee

Initiation fees are payable at the time of membership application.

Membership Dues

Membership dues may be paid annually or are billed quarterly, pro-rated for the quarter in which the member joins the Club. Upon acceptance of your application, you will receive a statement indicating the amount owing, which will depend on your choice of payment schedule.

Food & Beverage

Any food and beverage credits must be used within one (1) year of approval date. Any remaining amount after that time will be transferred to general Club revenues.

Athletic Facility

24 hour - 7 days a week access to the Club's Athletic Facility. Annual membership fee is \$450.00 or \$112.50 per quarter, including towel service. Locker rental is additional and includes laundering of athletic apparel. Spouses of members are eligible to join the facility based on the same fee structure.

Waiting List

The current membership limit of the Saskatoon Club is 650 members. You will be advised after receipt of your application of the current length of the waiting list and your position on it.

Signatures of a proposer and seconder

Club bylaws require two signatures from existing members of the Club in order for our board to review your application. Please ensure your application is complete before you submit it.

Categories

Local Active

Initiation fee - \$1200.00. Fee may be paid in lump sum at time of application or in quarterly installments over three years. Those applicants paying in lump sum will receive a \$100 Food and Beverage Credit. Annual dues - \$900.00 or \$225.00 per quarter.

Corporate

Initiation fee first member \$2,000.00, second member \$1600.00, third and subsequent members \$1200.00. Annual dues - \$900.00 (or \$225.00 per quarter) per member. Memberships may be transferred within the company for \$250.00.

Local Active (Associate)

Under (35) years of age. Initiation fee of \$600.00. Fee may be paid in lump sum at time of application or in quarterly installments over three years. Those applicants paying in lump sum will receive a \$50 Food and Beverage Credit. Annual dues of \$525.00 or \$131.25 per quarter. On reaching (35) years of age, the member will be transferred to Local Active membership and annual dues will be increased to \$850.00. No further initiation fee applies.

Non-Resident

Must reside beyond (60) kilometers of the City. Initiation fee of \$500. Annual dues of \$400.00 or \$100.00 per quarter. Member may not use affiliated Club privileges. No voting privileges at the Annual General Meeting.
